## **Major General Nabors' Priorities**

- 1. Continue critical missions
- 2. Create social distancing at all Wings/CRTC
- 3. Pay our Airmen (with flexibility and legality)
- 4. Communicate to the lowest levels
- Currently, three State Active Duty missions have been assigned to the MSNG
  - The 172 AW will man a mobile testing facility with 20 PAX
  - The ARNG has executed some PPE distribution operations
  - Several MSNG members are performing command and control operations
- One T10 mission has been assigned—the 186 AOG is standing up to augment 1AF with night shift operations
- Your Wing/CRTC Commander has been developing a UTA plan for you! Get in touch with your supervisor if you need information/clarification.
- Dispel the rumors! There has been no discussion regarding using National Guard soldiers and airmen to enforce quarantine or martial law. If you hear rumors on this subject, reiterate the TAG's message: Once activated, the missions of the MSNG will primarily consist of humanitarian support efforts. Examples of these missions could include logistical support, supply distribution, site set-up and support at drive-thru screening facilities in addition to supporting local and state civil authorities.
