SUBJECT: Notice to Airmen (NOTAM) 20-006

- **1. Statewide Shelter-in-place.** Governor Reeves has issued a shelter-in-place order for the State of Mississippi beginning 1700L, 3 April 2020, and ending 0800L, 20 April 2020. Lauderdale County's shelter-in-place order is extended to match the ending date of the state order. People may leave their homes to perform essential activities, such as caring for someone in the vulnerable population, getting food or necessary supplies, and working for an essential business. Restaurants may only remain open for drive-thru, curbside and/or delivery service.
- **2.** Travel Exemptions of the Mississippi National Guard (MSNG). Military personnel are exempted from statewide shelter-in-place travel restrictions when traveling to or from military duties ONLY. If encountered by law enforcement during exempted travel, military members should identify themselves using their Common Access Card (CAC) or identification badge and explain the nature of their work and travel. Adhere to local law enforcement directions and report any issues through your chain of command.
- **2. ID Card Issuance Changes.** In response to COVID-19, several exemptions to military ID card policy are now in effect through 31 Aug 2020.
- a. CAC's may only be renewed up to 30 days out from the expiration date and will not be reissued solely for rank changes or last name changes due to marital status.
- b. Dependent ID's will remain valid that expired on or after 01 Jan 2020 through 31 Aug 2020, if showing eligibility in DEERS. This does not apply to dependent children turning age 21 or 23 or secondary dependency these cards can be renewed. The minimum age for initial dependent ID card issuance has increased from age 10 to age 14 initial ID cards can still be issued.
- c. Remote DEERS updates are authorized.
